This agreement is entered into by and between the Waldron School District and «Name», for and in consideration of the mutual covenants and agreements set forth herein,

- I. The School District, District hereafter, by a majority vote of those members of its board of directors present at a legally held meeting on May 24, 2010, agrees to employ «Name» Employee hereafter, to perform the duties that are generally performed by «Job» including, but not limited to, the following specific duties: Clerical duties as assigned by supervisor and or administration.
